

Terms and Conditions of Prime Visa Online Card Application Offer

1. The promotion period of Prime Visa Online Card Application Offer ("Promotion") is from January 1 to December 31, 2019 (both dates are inclusive) ("Promotion Period"). Eligible Applicant as defined in clause 2 will entitle to one free tall size beverage at Pacific Coffee ("Application Offer") in this Promotion.
2. Prime Visa applicant who is an overseas domestic worker in Hong Kong, has been working with their current employer for 5 years or more; or has been working with their current employer for 2 years or more and serving in Hong Kong for accumulated 8 years or more; and who has at least 6 months valid working visa, must submit Prime Visa application form via OSW website (<http://m.primecredit.com/osw>) or via the Prime Gems mobile Application with all required documents upon card application (HKID card, CCSL card, Passport with valid visa, Residential address proof [Home Country and Hong Kong] and all relevant employment contract) within Promotion Period to be eligible to Application Offer ("Eligible Applicant"). Applicant who is currently holding / or has held any credit card issued by PrimeCredit Limited ("PrimeCredit") in the past 6 months or have received the Application Offer within the last 6 months is not eligible to any Application Offer.

Eligible Applicant is entitled to redeem any tall size (12oz) handcrafted beverage or Chillino (except specialty coffee, liqueur coffee, bottled drinks and juices).
6. The Application Offer sent via SMS must be redeemed on or before the deadline as stated in the SMS. Expiry date is non-extendable. The QR code is valid for one-time use only. The Application Offer is non-exchangeable, non-refundable and cannot be exchanged for cash. The Application Offer cannot be used in conjunction with any other promotions or privileges of supplier.
