

Terms & Conditions of PrimeCredit Grand Lucky Draw 2019 ("Lucky Draw") For product code 900 and 711

- 1. Promotion Period is from October 2 to December 31, 2019 ("Promotion Period", both dates inclusive).
- 2. There will be three (3) winners of a brand new Multi-purpose Vehicle ("Prize") which will be delivered to the winners' hometown in the Philippines. The Prize can only be used in the Philippines.
- 3. All eligible loan customers will be given one raffle ticket for every HK\$20,000 gross loan amount (in one transaction) upon loan draw down (i.e. 2 tickets for gross loan amount of HK\$40,000 and 3 tickets for gross loan amount of HK\$60,000) and all eligible credit card customers will receive two (2) raffle tickets during the credit card application submission.

- 11. PrimeCredit reserves the right to verify the identity of winners again after the publication of the results of the Lucky Draws. In case of disputes, the decision of PrimeCredit in this regard shall be final.
